Helping New Mexico’s Soil and Water Conservation Districts (SWCDs) build their capacity to provide services locally is the purpose of NMCCD. Formed in 2013, the Coalition assists Districts with the conservation of natural resources in New Mexico by providing comprehensive support and ethical representation. The Coalition provides a network of experienced Board members and staff to support and assist local Districts meet their local financial, organizational, and community needs.

What Does NMCCD Do?

- ◆ Assists with and encourages capacity building for Districts by locating funds to direct to SWDCs, providing staff training and support to respond to RFP’s, and providing project management guidance.
- ◆ Provides partnered support and professional representation during Legislative Sessions, meeting with Legislators, and attending committee meetings.
- ◆ Actively assists Districts with legislative funding applications, Legislative outreach, and attendance at legislative hearings.
- ◆ Provides a network of Board Members and Staff to assist and support districts with day-to-day operations, grant funding sources, alliance building, and community outreach.
- ◆ Acts as a frequently updated informational resource on state, regional, and national issues.
- ◆ Provides resources to educate on issues pertaining to natural resource management and conservation.
- ◆ Provides professional representation during Legislative sessions and committee meetings.
- ◆ Assists SWCD’s in responding to RFP’s and the project management process.

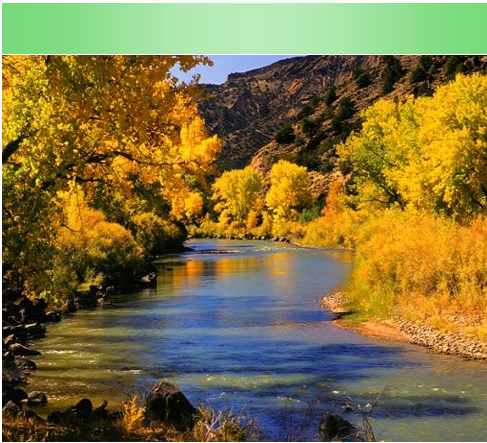

The Importance of Land Use Planning

Over the last couple of decades many Soil and Water Conservation Districts (SWCDs) have been increasingly concerned by increased federal regulations and restrictive land use designations. The concern stems from the view that such actions will reduce the economic viability of farms and ranches. The disbelief also stems from the misconception that agriculture alone is the sole reason many of our public lands are mismanaged.

So, what do we do about this alarming trend? We do our jobs as dictated by law. 73-20-44 NMSA 1978 states that, “a soil and water conservation district, organized under or perpetuated by the provisions of the Soil and Water Conservation District Act is a governmental subdivision of the state, a public body politic and corporate.” Districts may conduct a wide array of research, investigations, and surveys to facilitate conservation and development. Included, but not limited to, is the extended authority to develop comprehensive plans for natural resource conservation, development, and utilization including flood prevention, control and prevention of soil erosion and the development, utilization and disposal of water.

How do we implement the statute? Create a Land Use Plan. Protection of the customs and culture of the local area requires protection of the tax base, including the right to conserve, protect, encourage, develop and improve agricultural land for the production of agricultural products, and to reduce the loss to the state of its agricultural resources by limiting the circumstances under which agricultural operations may be deemed a nuisance.

The purpose of a Land Use Plan is to guide policy with respect to soil and water natural resource conservation. Land Use Plans should be designed to:

- (1) provide protection for the soil and water resources;
- (2) facilitate federal agency efforts to seamlessly coordinate joint efforts between federal, state and county land use decisions; and
- (3) provide strategies and policies for enhancing the conservation, improvement, and management of these resources.
